MODERNIZED HIGH SCHOOL CLASSROOM SPACE

- A new two-story high school building that replaces most of the learning space
- Upgraded classroom space that accommodates new learning requirements
- Upgrades to existing facilities, safety and mechanical systems



UPGRADED FACILITIES AND GENERAL MAINTENANCE

- Repair leaking roofs
- Upgrade heating, ventilation, and air conditioning (HVAC) systems
- General maintenance and building longevity projects

SAFETY AND SECURITY

- Seismic upgrades
- Health and safety upgrades at schools
- Physical threat security upgrades at schools
